General Terms and Conditions

The following general and specific terms govern birthday parties at Columbia Association (CA) facilities:

- A. Fees are based on the CA membership status of the birthday child.
- B. No nut products, gum or gummy candy or glass containers of any kind can be brought into the facility.
- C. The minimum charge for any party is 10 child participants. The maximum number of participants is 20.
- D. A deposit of the 10-child minimum charge must be paid at the time of signing of this agreement.
- E. The balance of the payment due must be paid 20 minutes after the start of the party.
- F. In the case of unforeseen circumstances such as power outage or inclement weather, CA reserves the right to close the facility. If the facility is closed during the scheduled party time, the party may be rescheduled by the person identified below as booking the party and signer of this agreement or CA will refund the amount paid for the party.
- G. The signer may cancel or reschedule with a minimum of 14 days notice (prior to the date of the party). If at least 14 days is given to CA, the deposit will be refunded minus a \$50 service charge. If less than 14 days notice is give to CA, the deposit will not be refunded.
- H. CA reserves the right at all times to cancel this agreement. If the agreement is cancelled by CA, CA's only obligation is to refund any fees actually paid to CA under this agreement.
- I. Children over 6 years of age are not allowed in the wading pool. Participants must demonstrate a safe swimming ability in order to participate in aquatic activities.

- Persons using CA facilities do so at their own risk and release CA from any claims, actions, damages and liabilities arising out of their use of the CA facilities and equipment. Non-CA member parents of the birthday party guest participants are allowed to enjoy the lounge areas of the facilities during the party.
- Birthday party participants whose behavior is aggressive or potentially harmful in nature, or who may pose a safety risk in any way as solely determined by the CA staff, will be required to be removed from the party area and/or facility. In such a case it is the responsibility of the signer to assure that the individual is removed.
- CA will not be held responsible for lost, stolen, or damaged personal property of any kind.

The signer of this agreement assumes the responsibility of assuring that party participants are released to a parent/guardian or authorized person and must wait until all party participants have been properly released.

The party area(s) must be left in the same good condition and repair it was at the beginning of the party. The signer of this agreement agrees to reimburse CA for any and all expenses involved in repairing or restoring the area(s) and any contents, structures, or objects therein to the condition required by this agreement.
